Liability Release: For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, I _____, as parent or legal guardian of _____, a minor (hereafter "Minor"), hereby grant permission to allow Minor to participate in one or more of the events to be conducted during the calendar year beginning January 1, 2016 and ending December 31, 2016 by USA Federation for Sport Cheering d/b/a the College STUNT Association ("USA Cheer") (the "Events"). I, in my own behalf and on behalf of Minor, further agree to release and to hold harmless USA Cheer, USA Cheer's Sponsors, (hereinafter "Sponsors"), the Hosting site, (university, hotel, convention center, high school) on whose premises the Events will occur (hereinafter the "Locations"), the affiliates of USA Cheer, Sponsors and the Locations and the respective directors, officers, representatives, members, agents and employees of USA Cheer and their respective affiliates (hereinafter collectively "Releasees") from any and all liability whether caused by negligence of the Releasees or otherwise for any claim, judgment, loss, liability, cost and expenses (including, without limitations, attorney's fees and costs) of or connected with the Events, including any claim arising out of or connected with any illness or injury (minimal, serious, catastrophic and/or death) that Minor may incur or sustain during the Events, all activities associated with the Events and while traveling to and from the site for the Events whether or not the Events actually occur. I further expressly agree to indemnify and hold harmless Releasees and Releasees' heirs, successors, assigns, executors and administrators against loss from any further claims, demands or actions that may subsequently be brought by Minor, me or any other persons on the account of damages of any character resulting to Minor in any way from foregoing activities. I further agree to reimburse and to make good to Releasees and loss or costs Releasees may have to pay as a result of any such action, claim or demand.

I, as parent or legal guardian of Minor, hereby warrant that I have read this Liability Release in its entirety and fully understand its contents. I, as parent or legal guardian of Minor, am aware that this Liability Release releases Releasees from liability and contains an acknowledgement of my voluntary and knowing assumption of the risk of injury or illness. I, as parent or legal guardian of Minor, further acknowledge that nothing in this Liability Release constitutes a guarantee that any of the Events will occur. Therefore, without reservation or limitations, I, as parent or legal guardian of Minor, hereby assign, transfer and grant to USA Cheer, its successors, assignees, licensees, sponsors, any television networks, and all other commercial exhibitors the exclusive right to photograph and/or videotape minor and to utilize such videotapes and photographs and Minor's name, face, likeness, voice and appearance as a part of the Events or in any other media now in existence or hereafter developed, in advertising and promoting the Events, in advertising and promoting similar future events or in advertising and promotions relating to USA Cheer without reservations and limitations. I, as parent or legal guardian of minor, further understand that neither USA Cheer nor any third party is under any obligation to exercise any of the foregoing rights, licenses and privileges herein granted. I, as parent or legal guardian of Minor, waive any right to inspect or approve the programs, copies thereof and any promotional materials related thereto.
